Abdelrazik's case. After receiving instructions from Ottawa, we confirmed the meeting to deliver Embassy's verbal response to Note Verbale MFA/AMER/7/1/2 received on March 20, 2006.

As instructed, the MFA was informed that we would "welcome Mr. Abdelrazik's release, that we will endeavour to facilitate his return to Canada and we would appreciate receiving consular access ASAP" (a note verbale was sent this afternoon as a formal response to MFA/AMER/7/1/2). MFA response was enthusiastic and it is clear that the Sudanese authorities have been anxiously awaiting a positive response from the Embassy as MFA colleague immediately followed up with detailed questions on Government of Canada's proposed action for Mr. Abdelrazik's return. Non-committal and vague responses seem to have sufficed for the moment, however, I was informed that a meeting with NSI would be confirmed shortly so that details concerning Mr. Abdelrazik's release can be confirmed and his return to Canada expedited.

It is crystal clear that GoS authorities are eager to have this problematic case resolved as soon as possible and that they will be most accommodating in assisting the Embassy with the facilitation of Mr. Abdelrazik's return to Canada. 

""" my MFA colleague was frank and well-informed about the details of this case as he asked detailed questions about the conditions for the release and plans for the return of Mr. Abdelrazik.

We expect to be called to a meeting with MFA and/or NSI shortly to iron out the details and conditions for the release and return of Abdelrazik to Canada. Vague responses will not be tolerated as I was asked during the meeting if "a release 48 hours in advance of the departure would suffice, would it be a Canadian Forces plane, how will we cope with the no-fly list, etc." Clear detailed instructions are required in conjunction with a defined list of conditions and/or steps that must be met for the release and return of Abdelrazik. Please note that the turnaround time for this meeting and the subsequent release of the individual is expected (in my view) to be very quick.



The MFA articulated the following conditions as mandatory for the release of Mr. Abdelrazik: confirmation of flight and travel arrangements; a Canadian must accompany him back to Canada; Mr. Abdelrazik would be released to our custody at Khartoum Airport immediately prior to the outgoing flight.

Secure telcon CND/ISI and KHRTM: Telcon was held AM Monday 20 March; participants were CND/Harris, CNO/Gaudet-Fee; ISI; KHRTM/Bones [HOM]/ Pawsey [Consul].

desire on the part of the Sudanese government to deal with this case for once
and for all: we judge as significant their verbal reference to a "permanent
solution" to this case. Despite a series of imitants over the last year, Canada
has maintained a constructive working relationship with the Government of
Sudan, and we believe that this is an example of the MFA and NSI going out of
its way (and possibly engendering a degree of political risk) on our behalf to
keep military intelligence from taking expedient measures to deal with the case
(military intelligence is the most powerful and impenetrable security agency in
Sudan, and operates with complete impunity - there is strong evidence that
most of Sudan's 'disappeared' did so at the hands of military intelligence).

What has been clearly and forcefully implied by the MFA is that this is, in effect, our last chance to deal with this case on positive terms. All three Sudanese agencies are losing patience with what they perceive as lack of Canadian action

when earlier openings presented themselves. If advantage of this opening is not taken by Canada, there is a clear implication that the MFA and NSI will simply cede this case to military intelligence Canada's position hitherto that this is a consular rather than security case simply does not hold water with them, regardless of what we think.

Next Steps: As discussed, we will explore travel options, working on the consensus reached during the telephone conversation that the routing KHRTM-Tripoli-Casablanca on Libya-based Afirqya Airways, connecting to the Royal Air Maroc flight to Montreal, offers the most secure route for accompanying Mr. Abdelrazik back to Canada. In previous correspondence, CND instructed the mission to determine flight possibilities using Royal Air Maroc; CND/Harris undertook to confirm the determining factors behind this instruction.

All parties to the telcon agreed on the urgency in determining subsequent steps. CND indicated that they would get back to the Embassy as soon as possible, and in advance of the Embassy meeting with the MFA scheduled for Wednesday, March 29.
