### RE: ABOUSFIAN ABDELRAZIK

On behalf of the Canadian Union of Postal Workers Winnipeg Local I am writing to you in your capacity as Minister of Foreign Affairs of Canada to inform you that we are hiring Abousfian Abdelrazik for one day, in order to protest the 1267 regime and the regulations implementing it in Canada.

In light of the fact that, Canada asked the UN 1267 Committee to delist Mr. Abdelrazik in 2007, with no success; and in light of the fact that the 1267 listing and delisting procedures violate fundamental principles of justice and fairness, We ask that you immediately:

- lift the sanctions imposed on Mr. Abdelrazik (something the previous government did in the case of Liban Hussein);
- contact all UN Security Council members to inform them that Mr. Abdelrazik's removal from the 1267 list is a diplomatic priority for Canada;
- and
- revoke the unconstitutional "United Nations Al-Qaeda and Taliban Regulations", which implement the 1267 regime in Canada.
